Thanks to everyone that made it to the General Meeting. We had some good food, and managed to get some work done before some pulling. It was a great day!!

General Meeting Minutes
July 24, 2010

Chris Beiter, President, called the meeting to order at 1:30PM at the Zellwood Track.

Items Discussed/Motions Passed

- The 2011 Super pull Date is January 21, 2011 and January 22, 2011. This will put us just after the Fly wheeler's January Show and just before Citrus County.
- NOCIA has approached us and would like to Host the PPL Pull in October. NOCIA would be putting on the Show Financially, and the Club will provide them with help in the areas of (Registration, Line-Up, Track assistance, etc). The agreed upon dates are Friday October 15, 2010 and Saturday October 16, 2010.
- A Protest Fee was discussed – The Protestor must have Cash, the owner of the protested tractor must tear down, that day, at the track. If the tractor is legal the fee goes to the owner, if the tractor is not legal or owner refuses to tear down- fee goes back to the protestor, the tractor loses all points earned to that date, and cannot pull again until it is inspected. “This will apply to all pull vehicles in all classes”. Fees will differ based on type of Tractor/Truck. Motion was made by Rob Waller for Garden Tractors \$100 Protest Fee; Todd Zellner made the 2nd- All in favor motion Passed. Effective 10/30/10
- Board will review Fees for other Classes as follows: Mini-Rods; Farm Tractors; V-8 Farm Tractors; Modified Turbo Tractors; Street Trucks; Modified Trucks; Diesel Trucks.
- Newly Adopted Garden Tractor Classes- After long discussions on engine sizes, HP, and tractor modifications it was decided to make all fair FATC would adopt two additional classes – Stock Altered, and Sport Stock: Motion was made by Rob Waller, Todd Zellner made the 2nd- All in Favor Motion Passed. Effective 10/30/10
- Updates to Mini-Rod Rules – After long discussion the following changes were made to the Min-Rod rules: Rob Waller made the Motion; Chris Beiter made the 2nd-All in Favor Motion Passed. Effective 10/30/10
 1. 6,000RPM limit
 2. MSD allowed with 6,000 RPM Chip
 3. Cast Iron Block and Heads Only
 4. Hydraulic Cam
 5. Single Carburetor –pump gas only (No Alcohol)
 6. Balancer must have Shield or Certification Card
 7. 400CI – Small Block Only
 8. Full fire Suit – to include Jacket, Pants, Gloves, Shoes, Neck Brace and Helmet.

General Meeting Minutes - continued
July 24, 2010

- Discussed the need to have an EMT with a vehicle at each pull. This is a requirement of our Insurance and we need to comply. Jeff Gregory will work on this on the Club's behalf.
- The members in attendance thanked Frank and his Wife for providing the food at our last two pulls. Milton will continue the food for this season, and we will be looking for Vendors for the upcoming pull season to start in March 2011.
- The members in attendance thanked Rob Waller for singing the National Anthem at our June Pull. We were having technical difficulties with the CD, and Rob took the opportunity to show us all his singing voice. He did a great job! All of appreciated the fact that our National Anthem was important enough to sing unprepared rather than not at all.

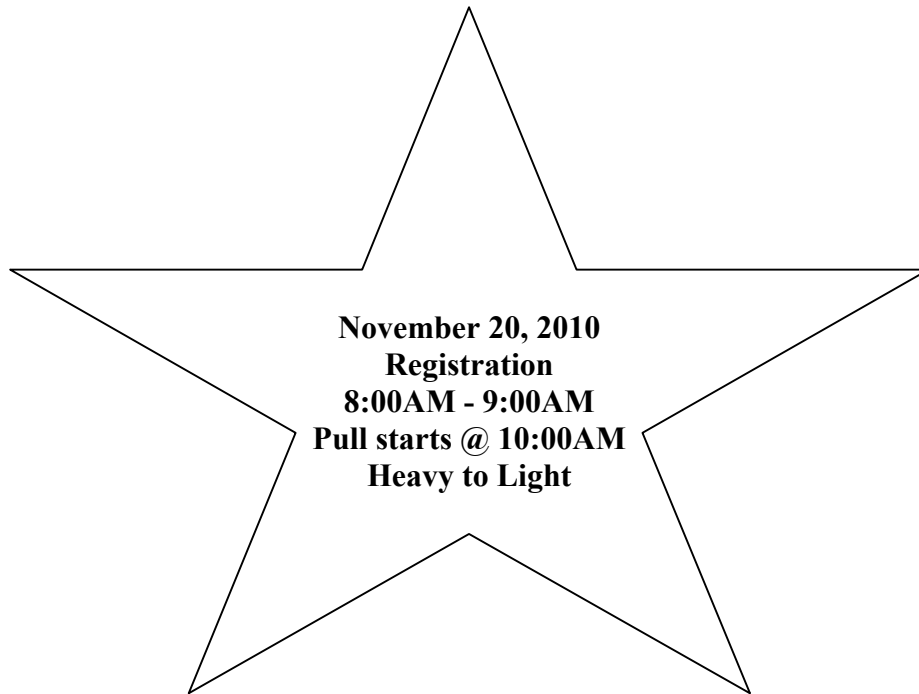
